Data Collectors will work on the Pittsburgh Hill/Homewood Research on Eating, Shopping and Health (PHRESH) project gathering data on how changes to the neighborhood (such as housing developments or park renovations) can influence the health of neighborhood residents. Work is expected to begin in May 2021 and will last through October 2021.

As a Data Collector, you will...

- Obtain cooperation of study participants by effectively answering questions and addressing concerns.
- Travel to respondent homes to administer social distant in-person surveys with selected participants in the Hill District and Homewood neighborhoods.
- Take participants' biometric measures (height and weight and blood pressure) during the in-person interview.
- Complete the required number of interviews during the data collection period while preserving the integrity and confidentiality of all information acquired, including signing a confidentiality agreement.
- Accurately complete all project documentation, including electronic survey instruments and all reporting forms.
- Maintain a professional, cooperative relationship with your Field Coordinator and other project staff.
